

Privacy Policy

At Førde for dialogue, we are committed to maintaining strong and meaningful privacy protections for visitors, partners and all individuals that are connected with us in any context. Our privacy policy is designed to inform you about the information we collect, how we use it, and your options about certain uses of information.

Førde for dialogue's privacy policy applies to website visitors, users, applicants, partners and any individuals that we have some personal information on them. It applies across the Førde for dialogue family of networks and the services we provide.

Information we collect and how it is used

We collect and use information when you interact with us, when you use our online services, and when you visit our website. This information is used to deliver a better and optimized services to you ; establish and maintain donation accounts and billing records; contact you about our services and direct offers to you to participate or support our activities; monitor website statistics; and manage and protect our networks. Information may also be aggregated or de-identified for business and marketing uses by us or by third parties.

Information provided to or used by third-party advertisers

Førde for dialogue and third-party services such as Google Analytics and Marketing services seek to provide content that is more relevant to your interests on the website, newsletter, services you use. Analytics and Marketing technology companies present on our website may place cookies on your browser when you visit our site, use device identifiers or use similar technologies to collect information about your activities on our website and may combine this information with similar information they obtain from other websites and apps. Information sharing

Førde for dialogue shares information within organization and only the relevant staff members have access to those information in order to do their job . You can limit our sharing of certain types of personal information within the organization by contacting us by e-mail or phone.

We may share information with our vendors and partners for business purposes and when necessary for them to perform work on our behalf. For example we use secure payment services to handle the payments.
